Business meeting adjourned,

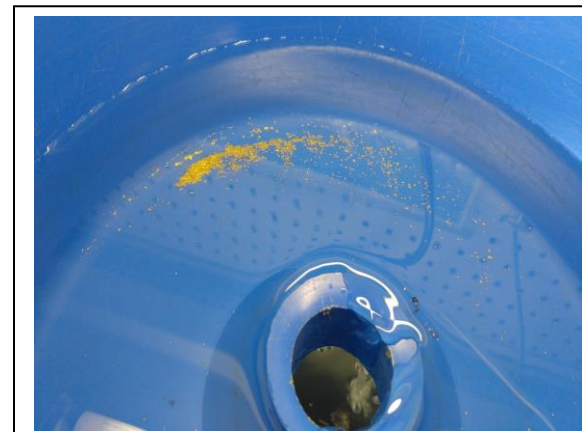

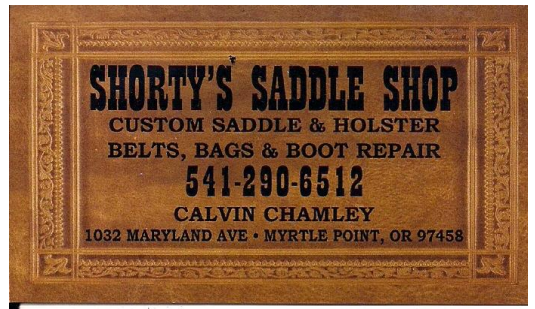
