This claim is up Lobster Creek about 16 miles. It was once known as OLD DIGGINS where Boulder Creek dumps into Lobster Creek. There's a lot of work needed to clean up this claim. Mostly tree and weed removal. We hope to get a bulldozer into the claim and smooth it out, so we can get trailers and tents down into the claim for camping and group prospecting. Otto reports that he found some pickers above the creek in the old channel. An outing will be planned later into the year to have a weekend outing on the claim.

If you haven't renewed your dues yet, it is time to renew. A Single person pays \$25.00 and a Family pays \$35.00 per year. All kids under 18 and the Mom and Dad are included.

We plan on 11-12 one day outings and about 8 weekend outings this year where we will camp out and prospect on one of our claims or a different place with proven gold.

Our first outing this year is planned for the "M&M" claim over near Ben Irving Reservoir on January 19th. If you're not sure how to get there we can meet at McKay's Grocery Store in Myrtle Point at 8:00 am and caravan from there. We'll plan on clearing brush and fallen trees but don't forget your prospecting equipment as we will dip a pan or five. Pray for NO SNOW!

I'm pretty sure we can bring this club back to the popularity it had 10 years ago. I love this club and I'm asking each of you to help me do that by inviting anyone you know who has an interest in prospecting to join the club.

We're trying something new this year. If you go to an outing, you'll receive a copper coin. If you go out of your way to help the club by selling tickets or cleaning up may also count.




