This claim has been used by 100 s of prospectors over the years and some think it is open to everybody. This is not the case. This property is private and only open to club members! In our by-laws we are required to wear our name badges at all outings and while on the claim. This helps identify us to other club members and the Forest Service if they chose to inspect the property. If you are on any of our claims and there is someone there that you don't know, be polite and find out if they are club members without badges. If they are not members kindly explain to them that they are on private property and ask them to leave. If they cause a problem, it would be best for you to leave. Get their license plate and description and call the Curry County Sheriff and report the claim jumping. THIS IS SERIOUS folks. They are stealing from you. It is a felony and needs to be addressed as soon as possible.

On another note, we canceled our outing to the M&M claim because of the torrential rain. I was looking forward to visiting this claim and looking for some gold. We'll have to schedule another outing for M&M before the water stops running.

Our February outing is a crabbing and metal detecting outing at Horsfall Beach boat ramp. Bring your appetite and metal detectors and enjoy the outing.

That's about all for now. I hope you will join us at the meeting on February 14th at 7:00 pm (6:00 pm for Board members)
