The Department of State Lands is initiating rulemaking to revise the Placer Mining General Authorization in OAR 141-089-0820 to 0835.

CAPTION: General authorization for recreational placer mining within essential indigenous habitat that is not designated state scenic waterways.

SUMMARY: In 2013, the Oregon Legislature passed Senate Bill 838, which imposes a moratorium on instream and upland motorized placer mining, effective Jan. 2, 2016. To comply with the moratorium, the Department of State Lands must revise the General Authorization for Recreational Placer Mining. The Department has filed a temporary rule that took effect on Jan. 2, 2016. The rule clarified the process for determining eligibility for the general authorization and removed certain limitations on placer mining that were established for the period ending Jan. 2, 2016. The agency is conducting permanent rulemaking and taking public comment starting in May 2016. The permanent rule will go into effect June 29, 2016.


